A special meeting of the Board of Trustees of the Village of Highland Falls was held in Village Hall, 303 Main Street, Highland Falls, New York on August 8, 2011.

The Meeting was called to order by Mayor D'Onofrio at 6:00 P.M.

The purpose of this meeting was to Enter Executive Session to discuss a personnel matter of a specific individual and contract negotiations.

Trustee DiSalvo motioned to purchase a new backhoe for \$69,362.35, which is the difference between the state bid list price of \$76,862.35 and a \$7,500.00 trade-in offer for the old backhoe, with the funding to come from appropriating additional surplus from the general fund balance and paid out of the 2011-2012 fiscal year budget.
