#### **REGULAR MEETING**

#### OF THE BOARD OF TRUSTEES

### OF THE VILLAGE OF HIGHLAND FALLS

# May 1, 2017

A regular meeting of the Board of Trustees of the Village of Highland Falls was held in Town Hall, 254 Main Street, Highland Falls, New York on May 1, 2017.

The Meeting was called to order by Mayor D'Onofrio at 7:01P.M.

Mayor D'Onofrio opened the meeting with a moment of silence for all our fallen soldiers and community members since the last meeting.

Trustee Aylward motioned to appoint Detective Jason Torpey to the position of Sergeant @ \$85,839/yr per contract, with maximum probation, 26 weeks.

The motion was seconded by Trustee Livsey and on a roll call vote, the results which follow:

A Public Hearing, as duly advertised, on the Dissolution of the Police Commission, was opened by Mayor D'Onofrio at 7:06pm.

Mr. Ned Kopald, Highland Falls, asked the Board what the reasoning was to dissolve the commission. Mr. Kopald commented that the Village could be well served by people not in a political position and should keep the commission.

Mayor D'Onofrio responded that the position has not been budgeted for, the Chairman of the Commission has resigned and that Orange County Civil Service did not recognize the commission. Mayor D'Onofrio responded that Trustee Livsey has been appointed Police Commissioner and the entire Board will oversee the operations of the Police Department. Mayor D'Onofrio commented that the main concern of this Board is public safety.

Trustee Aylward responded that the former Board chose to form the Commission and Orange County gave an opinion but did not say it couldn't be done.

Trustee Livsey commented that numerous meetings have taken place regarding this issue and there is a lot of work to be done.

All questions being asked and all comments being heard, Mayor D'Onofrio closed the public hearing. The Public Hearing closed at 7:14pm.

Mayor D'Onofrio introduced Dr. Frank Sheboy, Superintendent of the School District. Dr. Sheboy gave a brief overview of the upcoming school budget and encouraged the residents to come out and vote on May 16<sup>th</sup> for the new budget and three Board members.

Trustee Ramus motioned to approve the below listed minutes as follows:

The motion was seconded by Trustee Livsey and unanimously carried.

Trustee Aylward motioned to authorize Mayor Joseph D'Onofrio, Deputy Mayor James Ramus and Sergeant Jason Torpey to sign Stop DWI enforcement contracts for calendar year 2017.

The motion was seconded by Trustee Murphy and unanimously carried.

Trustee Livsey motioned to authorize Mayor Joseph D'Onofrio, Deputy Mayor James Ramus and Sergeant Jason Torpey to sign Orange County State Law Enforcement Terrorism Prevention Program (SLETPP) contracts for calendar year 2016.

The motion was seconded by Trustee Murphy and unanimously carried.

Trustee Aylward motioned to approve the request from the Recreation Department to hold a 3 on 3 basketball tournament at Roe Park on August 5<sup>th</sup> & 6<sup>th</sup> (raindate August 12<sup>th</sup> & 13<sup>th</sup>) from 7:00am -7:00pm The motion was seconded by Trustee Livsey and unanimously carried.

Trustee Murphy motioned to waive the \$50.00 live entertainment permit fee for the 3 on 3 basketball tournament sponsored by the Town of Highlands Recreation Department on August 5<sup>th</sup> & 6<sup>th</sup> (raindate August 12<sup>th</sup> & 13<sup>th</sup>) at Roe Park from 7:00am -7:00pm.
