Trustee Aylward motioned to authorize Mayor D'Onofrio to sign addendum#6 with the LA Group for services to be performed with regard to the DASNY grant for Roe Park Rehabilitation at a cost not to exceed \$10,000.

The motion was seconded by Trustee Livsey and unanimously carried.

Trustee Livsey motioned to transfer \$19,566.00 from A1990.1990(General Contingency) to A1910.0400(Unallocated Insurance) per the recommendation from the Village Treasurer.

The motion was seconded by Trustee Aylward and unanimously carried.

Trustee Livsey motioned to accept the low bid of \$201,500.00 from Kelleher Construction, Inc. for the North Main Street Sidewalk project to be funded with a multi-modal grant, per the recommendation of Village Engineer Todd Atkinson, PE.

The motion was seconded by Trustee Aylward and unanimously carried.
