September 17, 2019

A regular meeting of the Board of Trustees of the Village of Highland Falls was held in the Senior Center, 15 Drew Avenue, Highland Falls, New York on September 17, 2019.

The Meeting was called to order by Mayor D'Onofrio at 7:00P.M.

Mayor D'Onofrio opened the meeting with a moment of silence for all our fallen soldiers and community members since the last meeting.

A public hearing, duly advertised, for the purpose of presenting the Housing Choice Voucher 5 Year Plan was opened at 7:03P.M. Ms. Nancie Williams and Ms. Alisha Sedefian, representatives from Joseph E. Mastrianni, Inc. were present to provide information and answer questions related to the Housing Choice Voucher Program (Section 8) and the FSS (Family Self Sufficiency) Program. Ms. Sedefian spoke about the FSS program and reported that there are currently 24 vouchers utilizing this program. Ms. Williams answered questions regarding the Section 8 program and commented that it is a Federal funded program administered by Joseph E. Mastrianni, Inc. through the Village. Ms. Williams reported the Village currently has 64 vouchers. All questions being asked and all comments heard, the public hearing was closed at 7:14P.M.

Discussion was held regarding painting numbers on the sidewalks in the North End to assist the TOH Ambulance Corp with marking out vendor spots for their annual Fall Foliage Festival. The Ambulance Corps members came before the Village Board to request the numbers be painted on the sidewalks. The Mayor and Board members suggested they use chalk or some other non-permanent way to mark the vendor spots. The Mayor commented that the Village is spending hundreds of thousands of dollars to improve infrastructure in the North End of Main Street and would not like the sidewalks to be marked up.

Ms. Michele Reis, Representative of M&R Energy Resources presented to the Village Board a comparison of energy rates for the supplier of electricity, to review and discuss, as the contract period the Village is currently under expires in mid-October. Ms. Reis answered any questions the Board had and explained the process of going out to get these quotes from the different utilities.

Trustee Livsey motioned to accept Constellation as the supplier for electricity at the rate of \$0.05256kwh for 25 months and authorize the Mayor to sign the agreement after review by the Village Attorney.
