VILLAGE OF HIGHLAND FALLS RESOLUTION SETTING DATE OF REFERENDUM ON QUESTION OF WHETHER THE VILLAGE OF HIGHLAND FALLS SHOULD BE DISSOLVED

WHEREAS, on July 1, 2021, the Village of Highland Falls was presented with a PETITION FOR LOCAL GOVERNMENT DISSOLUTION pursuant to Section 779 of Article 17-A of General Municipal Law seeking the dissolution of the Village of Highland Falls, which Petition stated:

"We, the undersigned, electors and legal voters of the Village of Highland Falls, New York, qualified to vote at the next general or special election, respectfully petition that there be submitted to the electors of the Village of Highland Falls, for their approval or rejection at a referendum held for that purpose, a proposal to dissolve and terminate the Village of Highland Falls."; and

WHEREAS, on July 9, 2021, the Village Clerk certified that the Petition to Dissolve contained a sufficient number of valid signatures to initiate the dissolution procedure; and

WHEREAS, pursuant to Section 758(7) of General Municipal Law, within 30 days of the Village Clerk's validation of the Petition, the Board of Trustees must enact a resolution calling for a referendum and setting a date for the vote.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Highland Falls calls for a referendum setting forth a single political question to the electorate of the Village of Highland Falls (in the form proscribed by GML § 780):
