**WHEREAS**, the intent of the grant is to provide the Village of Highland Falls with financial assistance to support the study of dissolution of the Village of Highland Falls prior to the referendum on dissolution of the Village; and

WHEREAS, the amount of funds to be requested from the Local Government Citizens Re-Organization Empowerment Grant (CREG) Expedited Assistance Program is an amount not to exceed \$25,000, and

WHEREAS, the CREG program has a required 10% local cash match, now, therefore, be it

**RESOLVED**, that the Village of Highland Falls is the Lead Applicant in an application for financial assistance under the 2021 Local Government Citizens Re-Organization Empowerment Grant (CREG) Expedited; and be it further

**RESOLVED,** the Village of Highland Falls Board of Trustees authorizes the required local matching funds; and be it further

**RESOLVED**, the Village of Highland Falls Board of Trustees hereby authorizes the Mayor to submit the grant application; and be it further

**RESOLVED**, that the Mayor, Village Clerk, Village Treasurer and Village Attorney are authorized to undertake all actions necessary to effectuate this Resolution, which shall take effect immediately.
